Influenza Season 2009

Dear AHCCCS Providers:

Preparations for the 2009/2010 Influenza Season are well under way. The Maricopa County Health Department, Arizona Department of Health Services (ADHS), Vaccine for Children (VFC), The Arizona Partnership for Immunizations (TAPI) and other community stakeholders have been instrumental in developing a State strategic plan for this influenza season. AHCCCS and AHCCCS Contractors are working collaboratively with this group to ensure the community receives accurate and up to date information in a timely fashion.

In an effort to reduce the burden of communications coming into your office, AHCCCS Contractors have agreed to place updates on each Contractors' website. Your office can expect to continue receiving updates from other state agencies and associations for both seasonal and H1N1 influenza. Each AHCCCS Contractor has agreed to keep their websites updated with at least the latest information from Maricopa County, ADHS, VFC and TAPI. AHCCCS Contractors strongly encourage practitioners to pre-register to receive the H1N1 vaccine when available and assist public health in getting our community vaccinated. Please check your affiliated AHCCCS Contractors' websites for information regarding H1N1 updates, vaccine clinics and vaccine availability.

Effective 10/1/09 (unless the vaccine is made available earlier): H1N1 vaccine administration, when FDA approved, is to be billed utilizing CPT-4 code 90663. AHCCCS does NOT require the FB modifier for the H1N1 CPT-4 code 90663. Contractors should NOT require PA for H1N1 vaccine administration.

The AHCCCS FFS vaccine administration rate is \$15.43.

Please use the ICD-9 diagnosis code V73.89 for claims related to H1N1 inoculation/vaccination. The V-code V04.81 ("Need for prophylactic vaccination and inoculation against certain diseases--influenza") can be utilized. Note, the 5th digit is mandatory in this code, it cannot be just V04.8. AHCCCS will accept either V code to allow providers who have used V73.89 in the past to continue using it if that is what they are used to doing or allow them to use the more specific V-code for need to vaccinate for flu.

The CDC created two new ICD-9 diagnosis codes: 488.0 and 488.1 for claims related to the treatment of H1N1. These codes should be used for persons that are diagnosed with H1N1 infection.
