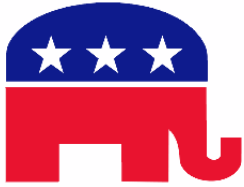




COCHISE COUNTY RECORDERS OFFICE POLITICAL OBSERVER PROTOCOL AND GUIDELINES



POLITICAL OBSERVER PROTOCOL

Arizona law allows for a political observer to be appointed by the county chairman of each political party that has a candidate on the ballot. Cochise County Recorders Office has established these protocols for party observers. We appreciate your following these rules.



<p style="text-align: center;">POLITICAL APPOINTMENT (A.R.S. §16-590)</p> <p>If you have been appointed as a Political Observer, you must have an original letter signed by the County Chairman of your political party and the County Election Official confirming your appointment. We cannot accept copies. This letter must be presented to the RECORDERS OFFICE along with proof of identification and photo ID.</p>	<div style="display: flex; justify-content: space-between; align-items: center;"> <div style="text-align: center;"> <p>QUESTIONS / CONCERNS CONTACT THE ELECTIONS DEPARTMENT DIRECTLY</p> </div> </div> <p>If you have any questions or concerns, please contact Cochise County RECORDERS OFFICE at 520-432-8358.</p>
<p style="text-align: center;">THE INSPECTOR</p> <p>The RECORDERS OFFICE is your only point of contact. The RECORDERS OFFICE has the responsibility to keep the election process running smoothly and without disruption. Please help the RECORDERS OFFICE by keeping your questions to a minimum.</p>	<p style="text-align: center;">VOTE CENTER ETIQUETTE</p> <p>the RECORDERS OFFICE can be very crowded, therefore, we ask that you conduct your observing as quietly as possible. If there is already a representative from your party at the RECORDERS OFFICE then one of you will need to leave, as only one per party is allowed.</p>
<p style="text-align: center;">75 FOOT LIMIT (A.R.S. §16-515)</p> <p>No person shall be allowed to remain inside these limits while the polls are open, except for the purpose of voting, and except the election officials, one representative at any one time of each political party represented on the ballot who has been appointed by the county chairman of such political party, and the challengers allowed by law. Voters having cast their ballots shall at once retire without the seventy-foot limit. A person violating any provision of this notice is guilty of a class 2 misdemeanor. The Marshal is responsible for ensuring that only authorized persons are in the Vote Center.</p>	<p style="text-align: center;">“DO’S AND DON’TS” FOR THE POLITICAL OBSERVER</p> <p>DO - Present your letter to the Inspector upon arrival. DO - Be careful not to disrupt the election process. DO - Call the RECORDERS OFFICE directly at 1-520-432-8358 with any questions or comments. DON’T – Wear any political attire or clothing within the 75’ limit. ARS 16-515(F) DON’T - Talk to the voters while they are within 75 feet of the Vote Center. DON’T - Ask questions of or talk to the RECORDERS OFFICE staff. The staff are present to assist the voters. DON’T - Enter a voting booth, unless you are entering the voting booth to cast your own ballot. DON’T - Touch the ballots or any voting equipment. DON’T - Use your cell phone or any other electronic device while in the RECORDERS OFFICE. Step outside the to make a call. DON’T – Eat or drink inside the RECORDERS OFFICE while observing.</p> <p style="text-align: center;">The RECORDERS OFFICE will ask you to leave if any of these rules are not followed. All voters, candidates, workers, property owners and the public deserve courtesy and respect.</p>
<p style="text-align: center;">CENTRAL COUNT FACILITY</p> <p>Political Observers may be present during significant activities at a central count facility, Elections Dept. or the Recorder’s Office during regular business hours when voted ballots are present. Under State law, a live camera feed is provided on the county website during times ballots are in the tabulation room when conducting a statewide election. You may view this live feed from any location offsite: Cochise.az.gov/elections</p> <p>Central county facility (Elections) will be open during receiving ballots and/or electronic media on election night only.</p> <p>There are no public restrooms in the central county facility and food and drink is not permitted. Observers are not authorized to wear any political attire or clothing inside the 75’ limit.</p>
