TO RUN FOR A SEAT ON YOUR LOCAL SCHOOL BOARD

An individual seeking election to the governing body of a school district must be a registered voter of this state and have been a resident of the school district for one year immediately preceding the day of election. No employee of a school district or the spouse of such employee may hold membership on a governing board of a school district in which they are employed. Persons related as immediate family who have the same household of residence within four years prior shall not serve simultaneously on the governing board of the same school district if the governing board is composed of five members.

- 1) Pick up an information packet, nomination paperwork, and Candidate ID number** from your Cochise County School Superintendent's Office, 3rd floor, Old Bisbee High School, 100 Clawson Ave., Bisbee.
- 2) Campaign Finance Statements: Submit as required.**
 - a) Statement of Organization – if spending more than \$500 on your campaign.
 - b) \$500 Threshold Exemption – if spending between \$250 and \$499 on your campaign.
 - c) De Minimus status - not required to file any paperwork if spending less than \$250.
- 3) Only after appropriate campaign financial documentation is filed** (or running De Minimus status) **start collecting signatures using Non-partisan Nomination Petition.**
- 4) File nomination paperwork between July 7, 2014 and August 6, 2014.**
Nonpartisan Nomination Paper (includes nomination, affidavit of qualification, and campaign finance laws statement) and **Nomination Petitions** (with signatures).
- 5) Candidates may submit a 500 Word statement and a 2x3 photograph** for publication on the Cochise County School Superintendent's website anytime from **July 7, 2014 through September 18, 2014.**

NOTE: All paperwork is filed with the Cochise County School Superintendent's Office.

The Non-Partisan Nomination Petition

The form is used for obtaining the required number of signatures of qualified electors in order for the candidate to have his/her name placed on the official ballot (A.R.S.16-314B). The form size is 8 1/2 x 11 inches. Petitions should be headed by a caption stating the purpose of the petition, followed by the body of the petition stating the intent of the petitioners. The purpose of the petition must also include the length of term for the candidate (2-year or 4-year). Format is ten lines spaced three-eighths of an inch apart and consecutively numbered one through ten. A photograph of the candidate may appear on the nomination petition. All petitions will be signed by a circulator who is qualified to register to vote in this state. The circulator's name is to be typed or printed under such person's signature. The circulator's actual residence address or, if no street address, a description of residence location shall be included on the petition. A voter may sign the number of candidate petitions equal to the number to be elected within that office. For example, in a school board election, if there are three seats up for election, a voter may sign up to three candidate petitions.

The Office of the County School Superintendent does not verify signatures on petitions; however they are subject to challenge. Nomination papers, Affidavit of Qualifications, petitions, and financial disclosure statements become public record once filed and are subject to inspection by the general public.

Nomination Paper, Affidavit Of Qualification, Campaign Laws Statement

The first of this three-section form is the Nomination Paper. Candidates must state office, date of general election and meet residency requirements. The second section of the form is the Affidavit of Qualification. The length of term must be stated and residence must be listed, as well as mailing address if different, and the exact manner in which the candidate desires to have his or her name appear on the official ballot. ***These two sections must be signed by the candidate and notarized.*** The third section, the Campaign Law Statement, requires the candidate's signature only.

Note: Names printed on the official ballot are limited to last name, first name, and middle names. Abbreviations, initials, and nicknames are permissible, but in no event shall nicknames, abbreviations, or initials suggest reference to professional, fraternal, religious, or military titles. Abbreviated names or nicknames MAY be printed with quotation marks. The candidate's last name will always appear first on the official ballot.

Write-In Candidates

Any person desiring to become a write-in candidate for a school board shall file a nomination paper signed by the candidate and notarized, giving his/her place of residence and post office address, age, length of residence in the state, date of birth (A.R.S.16-321A), the office for which candidate wishes to be a write-in, including division, type of election, date election is to be held and the name as you wish it to appear on the write-in ballots (A.R.S.16-311A). The nomination paper must be filed with the County School Superintendent's Office, 3rd floor, Old Bisbee High School Building, 100 Clawson Avenue, Bisbee by September 25, 2014.

Campaign Contributions And Expenditures

Itemized and detailed statements of campaign contributions and expenditures must be filed by each candidate's campaign committee. Candidates receiving and or expending less than \$250 are not required to register. More than \$250 but less than \$500 should file a Threshold Exemption Statement ([A.R.S. 16-903](#)). When a candidate's campaign committee or political committee has filed a \$500 exemption statement, receives contributions, or makes expenditures of more than \$500, the committee shall file a Statement of Organization within 5 days after exceeding the \$500.00 limit ([A.R.S.16-902.01 & 16-903](#)). Candidates who intend to receive contributions, or make expenditures of more than \$500 in connection with a campaign shall designate a political campaign committee by filing a Statement of Organization.

Posting Of Campaign Signs

Any candidate/political committee posting temporary political signs within city limits must first check with each city on any ordinance or regulations for posting political signs. Signs posted within the county shall not be placed in a manner that either obstructs or otherwise physically interferes with an official traffic sign, signal, or device ([A.R.S.28-7093.A.8a](#)). Signs shall not physically interfere with the vision of drivers in approaching, merging, or intersecting traffic. School districts, personnel, equipment, materials, building, or other resources shall not be used for the purpose of influencing the outcome of elections. Signs shall not be placed on trees, painted, or drawn on rocks or other natural features. For the posting of signs on private property, it is up to each candidate/political committee to contact the owners for permission. The Cochise County School Superintendent's Office is not responsible in any way for a candidate's political signs.

Candidate Statement For County Website

Per [A.R.S. §15-421](#), the County School Superintendent will publish the statement of each certified candidate on our website. The candidate statement consists of a recent photograph of the candidate and a statement not to exceed five hundred words. The County School Superintendent's office cannot modify or edit photographs or use copyrighted photographs without the permission of the copyright holder (e.g., Olan Mills). The candidate statement must be typewritten or electronically submitted. The statement will be posted verbatim as it is received. The County School Superintendent's office must have the statement at least twenty-one (21) days before early voting begins (September 11, 2014). The statement will be posted on the County School Superintendent's website no later than fourteen days before early voting begins (September 18, 2014). If a candidate does not submit a statement, the website will state "No response submitted" for the candidate. The candidate statements will be posted on the website alphabetically by district and by candidate's last name.
