## RESOLUTION 02- 111

Amending Resolution 02-99  
and  
Amending Certain Fees for Environmental Health Services

**WHEREAS** the Cochise County Health Department and the Cochise County Board of Health have recommended to the Cochise County Board of Supervisors that certain of the Environmental Health Fees as adopted on November 4, 2002, by Resolution 02-99, be modified; and

**WHEREAS**, the annual fees listed herein do not exceed the actual and reasonable costs of providing these services and are necessary in order for the County to continue to provide the same level of Environmental Health Services; and

**WHEREAS**, these proposed changes for the fees for hotels, motels, RV parks and certain establishments serving limited types of food are intended to address the comments that were received during the previous proceeding to amend these fees and the subsequent review; and

**WHEREAS**, this matter has been noticed for public hearing as required by A.R.S. §11-251.08, and following this hearing the Cochise County Board of Supervisors has determined that these proposed revisions to the Environmental Health Fees are necessary and appropriate.

**NOW THEREFORE BE IT RESOLVED**, that the following amendments to the Environmental Health Fees, as specified in the accompanying Attachment A, are hereby adopted under provisions of A.R.S. §36-187 and A.R.S. §11-251.08, to be in effect on and after December 10, 2002.






