FY17/18 CASE ASSIGNMENTS

There were 3,645 new cases assigned in FY17/18, an increase of 437 cases compared to the previous fiscal year. The PD and LD attorneys handled 72% of all new felony cases.



FY17/18 Interpreter expenses for the PD, LD, and IDC totaled \$6,348.

FY17/18 SPECIAL REVENUE FUNDS

Indigent defense used \$81,709 in special revenue funding to avoid expense to the general fund. Fill the Gap funds were used to support case tracking software upgrades and programming for the PD, LD and IDC offices. Funds were also used to partially fund an investigator for LD and a paralegal for PD. Training funds paid for the majority of mandatory CLE credits for PD and LD staff.

COLLABORATIVE PROGRAMS

- ◆ <u>Early Resolution Court (ERC)</u>: Indigent Defense continues to play an integral part in the ERC program
- ◆ Court Assisted Recovery Program (CARe): A diversion program in which the PD plays a central role by representing persons with mental health issues who are charged with misdemeanor offenses
- Criminal Justice Behavioral Health Task Force: Led by the PD, and attended by the IDC, County Atty, Adult Probation, Court Admin, NAMI and Veterans' Admin, the group meets to develop procedures to address/balance the needs of criminal justice and behavioral health
- ◆ <u>Jail Review Team</u>: PD participates in discharge management for jail inmates with behavioral health needs
- Interpreter Contracts: In November 2017, the Court Interpreters stopped providing out-of-court services for court appointed attorneys. The Public Legal Services team worked with Procurement to establish contracts with qualified interpreters to provide interpretation services.
