Tamah is preparing a powerpoint to share with the group to discuss online advertising options with Madden Media at a future date. Discussion only.
2. Jen Luria talked about the partnership between Bisbee and KVOA Channel 4 in Tucson. Bisbee has been running a successful summer commercial campaign on TV and online. Could possibly be a good partnership for CCTC. The group discussed would be best to get CCTC print ads designed and finalized before we can determine partnering opportunities. Discussion only.
3. Alan Baker presented a proposal from Nikon's Birding Adventure on Destination America TV. He suggested to split up episodes in order to promote each community and to share the cost (of \$14,000 for three 30-minute episodes). The videos would fit into our adventure marketing plan and we would be allowed to use both B roll and produced footage in our marketing outreach. Alan made a motion to wait and consider this proposal after the new budget is finalized and available. The motion was seconded by Del Cabarga.
4. Bob Nilson said he would contact Kartchner Caverns to see about what we can do with the Cochise County space we have in their lobby under our IGA with them. Once he has the details we can work on creating a nice exhibit to represent the county. Discussion only.
